### Applicability Scope

your machine to help the website to provide a better user experience. In general, *cookies* are used to keep the users preferences, hold information for items such as the shop cart and to provide anonymous data for the Google Analytics tool.

As a rule, *cookies* improve your navigation. However, you can disable the cookies in AMG BRAZIL's website and in other sites, by disabling your browser's cookies. By disabling the cookies in AMG BRAZIL'S website some functionalities may not be available. AMG BRAZIL is able to monitor the visitants' activities in its website using IP addresses and setting temporary cookies to monitor users' sessions. The data collected help us register the amount of visitants, and in this cookies there isn't any users' personal information collected.

### **Personal Data**
